Did You Know?

- The Administration for Children and Families (ACF) offers a variety of programs to support tribes with the Administration for Native Americans, HeadStart, Temporary Assistance for Needy Families (TANF), home visiting, etc.
- In Fiscal Year (FY) 2017, OCS awarded over \$33 million in LIHEAP funds to over 150 tribes and tribal organizations located in 23 states.
- Allocation amounts ranged from approximately \$650 to over \$2 million.
