- What is Public Participation?
 - It is a process that:
 - Directly engages the public in decision-making.
 - Gives full consideration to public input.
- What are the benefits of Public Participation?
 - Citizens are enabled to provide informed and timely input and influence decisions that affect the LIHEAP program.
 - Grantees will make better decisions.
 - Decisions will:
 - Be more easily implementable.
 - Reflect public interests and values.
 - Be better understood by the public.

Overview

This section provides an overview of the need for public participation.

Statutes

• LIHEAP Statute Section 2605(a)(2) states:

...no funds shall be allotted to such State for any fiscal year under this title unless such **State conduct[s] public hearings** with respect to the proposed use and distribution of funds to be provided under this title for such fiscal year.

• Block Grant Regulations at 45 CFR 96.48(d) states:

Public Hearings not Required for Tribes ... An Indian tribe or tribal organization is not required to comply with section 2605(a)(2) of the Act ...

Preparing for Public Input

- Before getting public input, know what your program does
- Good to have a base set of policy and procedures in place before going out into a public setting
 - Questions will be asked
 - Be transparent in what you do
 - Goal is to be accessible and to help people
 - Have policies to increase your chance of getting a response from the community

How Did I Start Developing the Public Input Survey?

- Community needed to know about LIHEAP
- Highly recommended during the 2015 OCS review team visit
- Learned that it was helpful to have public input

What Was I Seeking in the Public Survey?

- Surveys were done in the past, but did not serve to see what the public wanted from LIHEAP
- New survey would serve two purposes:
 - Provide information about what LIHEAP can do
 - Ask what they would like to see in the program
- Public needs to provide good input of what is needed
 - Clients are not always knowledgeable about the LIHEAP program
 - This is very helpful information

Places Where We Had the Surveys

- Did not have much time to get the survey out before the next annual plan was due
- Went out to 5 local districts: Gibson, Lincoln Creek, Fort Hall, Ross Fork, and Bannock Creek
 - Held monthly meeting with the general membership living in the area
 - Included a council member representative to hear the concerns of the people
 - Able to find the most vocal of general membership
 - Important to have policies in place and also to be as transparent as possible

Changes Made Because of Public Input

- Increase in the benefit amount to the most vulnerable populations
- Flexibility in crisis assistance
- Because of these changes, they have been well-received by the public

Why We Need Public Input

- Even though not required by tribal programs, it is strongly recommended
- Helpful in cases where we might not notice something that the general public may view as common knowledge
- Can double as an assessment of how well you are serving the community
 - What things can be improved upon from public comment?
- Able to hear from the most vocal members of the community about what can be improved

Future Plans For Public Input

- Goal this year is to have a bigger public input to see what the community would like to see with LIHEAP
- Plan to visit places that would have the most community members located in one spot at one time
- Want to host more weatherization classes for the community to gather more input on what they see is needed
- Will incentivize opinions with prizes that are related to weatherization and home improvement




